Acceptable Formats

To be considered for participation in the ConvergeSouth Film Festival, a prospective participant (hereinafter "Participant") must submit the work to be judged along with this application, electronically with uploaded submissions, or in hard copy with DVD submissions. Electronically uploaded submissions must be in NTSC DVD, NTSC VHS, NTSC MiniDV format. DVDs submitted must be viewable in ordinary US DVD players. PAL format is not acceptable. Each work to be submitted must be accompanied by a separate application.

By submitting a work for review, the Participant agrees to the following terms:

1. The obligation of ConvergeSouth, its producers, managers, presenters and others acting in support of the ConvergeSouth conference (all hereinafter "ConvergeSouth") to receive the work submitted to ConvergeSouth (hereinafter "Work") and include it in the judging shall be consideration for the Participant's granting the rights set forth in this agreement.
2. ConvergeSouth shall have the right to copy, display or perform publicly, create derivative works from, and distribute any work submitted to ConvergeSouth in connection with a ConvergeSouth conference.
3. The Work may be included with works submitted by other Participants in presentations during the ConvergeSouth conference.
4. Each work will be reviewed by a committee and rated for creativity, production value, originality and over all impact. The final judging will be by a panel of industry professionals. No Work is guaranteed of being selected by the committee for final judging, nor is any Work guaranteed of being selected by the panel of industry professionals as the winner.
5. The Participant represents that the Work was originally created by the Participant and that the Participant has full right to submit the Work, and has the full right to grant the rights given to ConvergeSouth in this application.
6. To the extent the Work includes the property of others, Participant has given due credit to each person whose property is included and obtained from those persons all rights necessary for ConvergeSouth to exercise all the rights received under this agreement.
7. Participant shall indemnify, and hold harmless ConvergeSouth from and against any losses, damages, liabilities, fines, penalties, and expenses (including reasonable attorneys' fees) that arise out of or result from any proved or unproved claim related by circumstances to Participant's submission of the Work to ConvergeSouth. Participant shall defend or settle, at its own expense, any demand, action or suit on any claim for which it is the indemnitor under the preceding sentence. ConvergeSouth and shall notify Participant of any assertion of any Infringement Claim.
8. Participant may market the Work to domestic and international distributors during a ConvergeSouth conference, provide that it does not interfere with nor, in the sole opinion of ConvergeSouth, create an undue burden on ConvergeSouth.
9. This agreement constitutes the entire agreement between the parties with respect to the subject matter of this agreement and shall not be modified or rescinded, except by a writing signed by Participant and duly authorized representatives of ConvergeSouth.
